#### **Reporting & Parents' Evenings**

#### **Frequency of reporting**

- At Kingwood we report every term (x6 reports p/a) This is a very good thing. Frequency is just right. Prevents any shocks. Parents say that their child really likes it – they enjoy bringing it home. It's great to prompt conversations between parent & child.
- The format of both the 5 Termly Reports as well as the Full Report Would like a reply slip on the termly reports for parent to communicate with form tutor e.g. to raise an issue with a particular subject. Reports found to be clear and helpful
- Is a Full Report still necessary/useful in light of substantial increase in overall reporting frequency? Could just have a full written in Y7 – overall not keen Parents love the personal nature of it – you know that the teachers know your child
  - Parents like the ability on the full report to send a comment back.

Parents like the way it reflects your child in a different light e.g. a teacher comments on leadership skills that they did not know their child had.

It's great for children to refer back to extract information e.g. for CV's

Parents quite happy to see character limit reduced to 500 (from current 1000) and focus being on successes and areas for development
